A bifacial solar panel is a type of solar panel that can collect energy from both sides - the front side and the rear side. A normal monofacial panel, on the other hand, can only collect energy from one side.

Can solar power help Cambodia achieve national electrification goals?

Searching for alternative options, Cambodia joins a growing list of national governments who have come around to seeing solar and other distributed, emissions-free renewable energy resources as a cost-effective means of achieving national electrification, as well as national and international climate change and renewable energy goals.

With the removal of this exemption, the cost of imported bifacial solar panels, typically ranging from \$0.10 to 0.25 per watt, will increase by \$0.015 to \$0.0375 per watt. For commercial projects with installation costs between \$1.50 and \$2.75 per watt, these increases will result in system price hikes of about 1-2%.

Bifacial solar panels generally used in utility-scale solar projects are not currently subject to safeguard tariffs under Section 201 of the Trade Act of 1974. Since this exclusion was implemented by the previous Administration, imports of bifacial panels have surged, now making up nearly all U.S. solar panel imports and undercutting the ...

In January 2018, President Trump concurred with the ITC recommendation to impose a four-year "safeguard measure" on foreign solar panels. The tariffs began at 30% but declined over time to 15%. A February report by the U.S. International Trade Commission determined that U.S. imports of bifacial modules doubled between 2020 and 2022.
