

# Import tariffs on energy storage products in Ho Chi Minh City Vietnam

What is Vietnam's custom tariff?

Vietnam's custom tariff is dependent on the type of product and whether it is regulated by the government. Vietnam's custom tariff comprises two parts: the import duty and the value-added tax (VAT). The import duty is a flat rate that is applied to all imported goods.

How does the Vietnam export tariff work?

In necessary cases, the Government of Vietnam submits to the Standing Committee of the National Assembly to amend and supplement the Export Tariff according to the List of Taxable Goods Groups and the framework for export tax rates for each taxable group issued together with this Law.

What goods are subject to higher import tariffs in Vietnam?

Generally, using an article from Vietnam Briefing, luxury goods such as cars and perfumes are subject to higher tariffs, while machinery and non-domestic consumer goods are pegged to lower import tariffs. When clearing customs, you will be expected to pay import taxes; failure to do so may result in goods clearance delays.

The proposed tariff reductions would see MFN tariffs on certain types of cars fall from 45-64% to 32%. The import tax on LNG would be reduced from 5% to 2%, while ethane would be exempted entirely. Wood and wood products would see tariffs drop from 20-25% to 5%. Ethanol would be taxed at 5% instead of the current 10%.
