



# Photovoltaic inverter warranty terms

How do I register a photovoltaic inverter warranty?

The "Registration Form" is the Photovoltaic Inverter Warranty Registration Form as set forth in SUNGROW's website. The Registration Form must be completed and returned to SUNGROW. 1.7. "Reaction time" means the time between the claim is accepted by SUNGROW officially and the Service is provided. 1.8.

What is excluded from a warranty on a photovoltaic inverter?

Any damage to the inverter that originates from the remaining components of the photovoltaic installation or damage that does not adversely affect the proper functioning of the inverter, i.e., for instance, "flaws", shall be likewise excluded from the manufacturer's warranty.

What is covered by the warranty on a Sungrow inverter?

The warranty shall only be applicable to the inverter unequivocally identified by the serial number. The remaining components of the photovoltaic installation and the Sungrow system accessories (e.g. PV array combiner box, PVS) shall not be covered by the warranty. Force majeure (violent or stormy weather, lightning, overvoltage, fire etc.).

What if the warranty period is less than 1 year?

If the warranty period left of the original product is less than one (1) year, the warranty period will be extended to one (1) year since the date of the replacement is done. Any parts that are replaced may be new or reconditioned. All parts replaced by SUNGROW shall become the property of SUNGROW. 2.7.

What is Huawei fusion Solar Advanced warranty services?

Advanced warranty services: The services to be provided by Huawei for free during the standard warranty period, only if the related product is connected to Huawei FusionSolar SmartPVMS. If the product is not connected to Huawei FusionSolar, or has been disconnected for over 6 months, the advance warranty shall be void.

The warranty start date varies according to the manufacturer: it can be the date of production, the date of purchase, or else the delivery or installation date.
