Should India impose anti-dumping duty on solar glass imports from China and Vietnam?

India's Directorate General of Trade Remedies (DGTR) has recommended an anti-dumping duty on solar glass imports from China and Vietnam after its investigation concluded that imports from these countries are undercutting the prices of the domestic industry.

Are solar glass imports a problem in India?

The Directorate General of Trade Remedies (DGTR) found that these imports, which account for 98% of India's solar glass needs, significantly undercut local prices and recommended the duties. What does SAMA say?

Which countries import solar glass to India?

In its investigation, DGTR noted the solar glass imports from China and Vietnam (totaling 779,017 MT) constituted almost the entirety of the imports into India, with a share of 98% during the period of investigation. Imports from China grew from 29,324 MT in 2020-21 to 659,732 MT during the period of investigation.

Will ESMC impose import duties on solar glass?

"Similarly, following disclosure, the union solar industry association ESMC submitted that maintaining import duties on solar glass would be difficult for current union solar module manufacturers as it increases their costs for glass, while modules imported into the union are not subject to such tariffs, even where Chinese glass is used."

Why do IPPs have to pay anti-dumping duty on solar glass?

In this case, IPPs may invoke this clause to recover the additional costs caused by the anti-dumping duty on solar glass, as it was an unforeseen regulatory change. This would allow them to pass on the increased costs to buyers or adjust tariffs, ensuring the financial viability of their solar power projects.

Which countries import textured tempered glass?

The investigation revealed that imports from China and Vietnam accounted for 98 percent of India's textured tempered glass imports, totaling 779,017 metric tonnes by the end of the review period. These imports were priced lower than domestic products, hindering local manufacturers' ability to adjust prices to cover production costs.
